WHEREAS, The Lumbee Tribe of North Carolina (“Lumbee Tribe”) is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina (“Tribal Constitution”) and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina (“Tribal Council”), and;

WHEREAS, The Lumbee Tribal Council in conjunction with the Lumbee Tribe Finance Office is responsible for the oversight, and management of tribal funds, and;


WHEREAS, Our organization has received a letter of agreement from the Boys & Girls Clubs of America dated **March 5, 2025** for grant number **SOUTHERN SPIRIT OJJDP 2024-54334**, a federally funded grant in the amount of **\$20,000** to be used for **OJJDP 2024 Mentoring in Native American Clubs**, and;


