ORDINANCE AUTHORIZING THE ARCHIVING AND PUBLICATION OF TRIBAL COUNCIL COMMITTEE MEETINGS

WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers of self-governance; and,

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Triba Council of the Lumbee Tribe of North Carolina ('Tribal Council'); and,

WHEREAS, Transparency, accountability, and member engagement are central to the governance principles of the Lumbee Tribe; and,

WHEREAS, In the interest of enhancing public trust and ensuring that Tribal members have access to the decisions made in committee meetings, the Tribal Council deems it necessary to archive the motions, actions, and votes of all Tribal Council Committee Meetings.

THEREFORE, Be it enacted that the Tribal Council of the Lumbee Tribe of North Carolina, in an effort to increase transparency and promote greater engagement among tribal members, does hereby approve the following measures regarding the publishing and archiving of Tribal Council Committee Meetings:

- 1. The motions, actions, and votes of all Tribal Council Committee Meetings shall be transcribed by the committee secretary or committee designee in the absence of the secretary and submitted to Tribal Administration within ten (10) business days following the conclusion of the meeting. These motions, actions, and votes shall be kept in a secure archive for member review.
- 2. The motions, actions, and votes of all Tribal Council Committee Meetings, excluding those held in executive sessions or pertaining to confidential matters as outlined by Tribal policy, shall be made accessible via the official software system for members services of the Lumbee Tribe to active members only.
- 3. The Tribal Administration shall inform members of the availability of archived motions, actions, and votes of all Tribal Council Committee Meetings.
