"COLLABORATIVE COMMUNITY BENEFIT FOR TRIBAL MEMBERS"

WHEREAS, The Lumbee Tribe of North Carolina, a recognized Indian Tribe of the State of North Carolina, is governed by the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and,

WHEREAS, Article VII Section 1-b of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and,

WHEREAS, The Lumbee Tribal government was established to preserve the Lumbee way of life and community, while promoting the educational, cultural, social, and economic well-being of Lumbee people, as well as securing justice and freedom for the Lumbee people; and,

WHEREAS, The Lumbee people must feel secure in their rights and benefits afforded to them as duly enrolled tribal members of the Lumbee Tribe of NC; and,

WHEREAS, The Tribal Council possesses the authority and fiduciary responsibility to seek and secure all avenues of economic development on behalf of the actively enrolled tribal membership; and,

THEREFORE, Be it enacted that the Lumbee Tribal Council hereby establishes the Collaborative Community Benefit for Tribal Members program, aiming to create economic collaboratives with the Area Chambers of Commerce within the Tribal Territory of Scotland, Robeson, Hoke, and Cumberland Counties, in order to provide value-added benefits to tribal membership; and,

THEREFORE, Be it further enacted that the Tribal Council charges the Tribal Administration with the duty to initiate and maintain dialogue with the Area Chambers of Commerce within the Lumbee Tribal Territory, with the goal of securing value-added rewards and benefits for tribal members who may not have access to such benefits elsewhere; and,

THEREFORE, Be it further enacted that the Tribal Administration shall report back to the Tribal Council within 6 months on the progress made in establishing these collaboratives and any benefits secured for tribal members.
