WHEREAS, Article VII, Section I of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

WHEREAS, The Tribal Council has the authority to approve, enact and amend the annual fiscal budget and budget process; and

WHEREAS, The Tribal Council is responsible for oversight and review of all budget components; and

WHEREAS, The Tribal Council has authority and fiduciary responsibility to ensure compliance with program funding and allocations; and

WHEREAS, The Lumbee Tribe of North Carolina has received a grant from Three Star Government Solutions, LLC via SAMHSA of the US Department of Health and Human Services in the amount of \$25,000; and

WHEREAS, The grant will be administered to work on the development, finalization, implementation, and sustainability of a Community Prevention Plan/Community Sustainability Plan to address and prevent mental and substance use disorders and suicide, and to promote mental health; and

THEREFORE, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance shall be cited as the "Substance Abuse and Mental Health Services Administration, Tribal Training & Technical Assistance Center Grant Budget" subject to all inclusions and provisions as described in the budget.
