WHEREAS, Our organization has received a letter of agreement from the Boys & Girls Clubs of America dated March 5, 2025 for grant number TWO STREAMS OJJDP 2024-54335, a federally funded grant in the amount of \$20,000 to be used for OJJDP 2024 Mentoring in Native American Clubs, and;
