"Amendment to CLLO-2021-0819-01: Suspension of the Lumbee Tribal Constitution Reform Committee (TCRC)"

WHEREAS, The Lumbee Tribe of North Carolina a recognized Tribe of the State of North Carolina Subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and,

WHEREAS, Article VII, Section 1 of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and,

WHEREAS, The Lumbee Tribal Constitution formally adopted November 7, 2000 serves as the governing document of the Lumbee People; and,

WHEREAS, The Lumbee Tribal Council enacted CLLO-2021-0617-02 on June 17, 2021, establishing the Lumbee Tribal Constitution Reform Committee (TCRC) to assist the Tribal Council Constitution and Ordinance Committee in the reform process; and,

WHEREAS, On May 5, 2024, the TCRC submitted proposed amendments to the Lumbee Tribal Constitution, which now require thorough review and consideration by the Constitution and Ordinance Committee of the Lumbee Tribal Council; and,

WHEREAS, The Lumbee Tribal Council acknowledges the importance of ensuring that any constitutional amendments or reforms are conducted transparently, with proper vetting, and in accordance with the interests of the Lumbee People; and,

THEREFORE, Be it enacted that the Lumbee Tribal Constitution Reform Committee (TCRC) shall be suspended at the conclusion of 30 days.

THEREFORE, Be it further enacted that no further actions by the TCRC will take place until this review and determination process is complete, ensuring that the reform process is carried out with appropriate oversight and alignment with the Lumbee Tribal Constitution and the will of the Lumbee People. This amendment shall be incorporated into the existing ordinance "The Establishment of the Lumbee Tribal Constitution Reform Committee Guidelines," and cited as such.
