## RESOLUTION FOR TRAVEL FOR ECONOMIC DEVELOPMENT MEMBERS

WHEREAS, The Lumbee Tribe of North Carolina (“Lumbee Tribe”) is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina (“Tribal Constitution”) and its inherent powers and self-government; and,

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina (“Tribal Council”); and,

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina takes oath to promote the economic well-being of the Lumbee people; and,

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina designated the amount of \$30,000.00 for the Economic Development Committee; and,


WHEREAS, The \$30,000.00 will be used to fund conferences and training for the Economic Development Committee members; and,

WHEREAS, Attending conferences, gaining information, and training provide, offer, and enhance economic opportunities for the Lumbee Tribe of North Carolina; and,

THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby support members of the Economic Development Committee to attend conferences and receive training with the funds provided for the committee.
