WHEREAS. The Tribal Council is responsible for oversight and review of all budget components; and

WHEREAS, The Tribal Council has authority and fiduciary responsibility to ensure compliance with program funding and allocations; and

WHEREAS, The Lumbee Tribe "Department Of Justice/Office On Violence Against Women Grant Budget" Budget" is amended per the Department of Justice as stated; and

**THEREFORE**, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance shall be cited as the "Department of Justice/Office on Violence Against Women Grant Budget" subject to all inclusions and provisions as described in the budget.
