WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;


WHEREAS, The Lumbee Tribe acknowledges North Carolina Governor Cooper's Order related to COVID-19, which makes it prudent to close the tribal enrollment for the health and safety of tribal members, and;

WHEREAS, Pursuant to CLLO-2010-0121-01 amended May 16, 2019, the Tribal Chairman has recommended the closing of Tribal Rolls effective immediately upon approval by the Lumbee Tribal Council and;


THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby declare the tribal rolls closed for new enrollees until further notice.
