WHEREAS, The Tribal Council has the authority to approve, enact and amend the annual fiscal budget and budget process; and

WHEREAS, The Tribal Council is responsible for oversight and review of all budget components; and

WHEREAS, The Tribal Council has authority and fiduciary responsibility to ensure compliance with program funding and allocations; and

WHEREAS, The Lumbee Tribe of North Carolina has received a grant from Blue Cross Blue Shield of North Carolina Foundation in the amount of \$18,000; and

WHEREAS, The grant will be administered to address health assessment data; and

THEREFORE, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance shall be cited as the "BCBS Health Assessment Grant Budget" subject to all inclusions and provisions as described in the budget.
