## “USDA FOREST SERVICES CFP & LSR CAPACITY GRANT BUDGET”

**WHEREAS**, The Lumbee Tribe of North Carolina, a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and

**WHEREAS**, Article VII, Section I of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

**WHEREAS**, The Tribal Council has the authority to approve, enact and amend the annual fiscal budget and budget process; and

**WHEREAS**, The Tribal Council is responsible for oversight and review of all budget components; and

**WHEREAS**, The Tribal Council has authority and fiduciary responsibility to ensure compliance with program funding and allocations; and

**WHEREAS**, The Lumbee Tribe of North Carolina has received a grant from First Nations Development Institute via US Department of Agriculture in the amount of \$12,000; and

**WHEREAS**, The grant will be administered to develop a comprehensive plan for identifying historically significant properties within the Lumbee Tribal territory and to prepare for a larger USDA forestry grant; and

**THEREFORE**, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance shall be cited as the “USDA Forest Services CFP & LSR Capacity Grant Budget” subject to all inclusions and provisions as described in the budget.
